EDITORIAL NOTE


THE Record of Former Pupils serving in the War was commenced in the end of 1914 by the late Mr J. J. Trotter. On his death it passed into my hands. In 1917 the work was taken up by Mr Gray, subsequently assisted by Miss Mackerchar, and put into form for publication on the lines laid down by the Executive Committee of the War Memorial Fund. In 1920 Mr J. C. Stewart undertook the work of revising the MS., reading the proofs, and seeing the volume through the press. All those who from time to time have been in charge of the work received willing assistance from the other members of the staff.

It has been thought well to confine the scope of the Roll to a simple record of facts. The following information has accordingly been aimed at in each case: the date of leaving School, scholastic and athletic distinctions gained at School, and a record of naval or military service. To have attempted anything in the nature of biographical appreciation must inevitably have led to inequality of treatment; and where there was uniformity of endeavour there should be uniformity of recognition.

In its present form the Roll contains 929 names. The number of those who fell is 174. An official copy will be preserved in the School, and any corrections or additional information sent to the Editor at the School will be embodied in this copy.


