INSTRUCTIONS

For Angus Machetory Officer of the Fishery at Leth

for carrying into Execution the Act 1 Geo. IV. Cap. 103.

You will receive herewith Copy of the Act 1 Geo. IV. Cap. 103, intituled "An " Act for the further Encouragement " and Improvement of the British Fish-" eries;" together with a Copy of Regulations made by the Commissioners for the Herring Fishery, in virtue of the 7th Section thereof, directed to be observed by all persons claiming the Bounties granted by the said Act; and in an Appendix to these Instructions, are Forms of the several Documents necessary for carrying the Act into execution, numbered from 1 to 24, both inclusive. You will likewise receive herewith 4 Books for recording your Proceedings daily, as they occur, which are respectively titled on the Back, "Cod and "Ling Open Sea Fishery Tonnage "Bounty," "Cod and Ling Coast Fish"ery," "Cod and Ling, Oil and Whale"bone Bounty," "Cod and Ling Expor"tation." The duties you have to perform will appear by the said act and
regulations, which you will frequently
peruse with care and attention, so as to
make the provisions thereof familiar to
you: and in executing the same, you
will proceed, in so far as the circumstances of the case will permit, in the same
manner as is pointed out by your instructions under the herring fishery acts,
with which you are already familiar.

It is therefore considered necessary merely to state, that when a person signifies to you his intention of fitting out a vessel for the cod and ling fishery on the tonnage bounty, you will supply him with Form No. 1. of an entry to be filled up; will grant a certificate, according to Form No. 2. of the articles shipped, which you are to see put on board; with Licence, according to Form No. 3., if you are satisfied that the vessel is properly manned, furnished, and equipped for the voyage; and with Form No. 4. of the Journal to be kept by him. Upon the return of the vessel to port, after having completed the voyage, you will muster

the crew, according to the Form on the back of the Licence; will receive from the master his Journal, the truth of which is to be sworn to by him before you; and will also administer an oath to him, according to Form No. 5. When the fish are to be inspected, you will supply the adventurer with a Request Note, according to Form No. 6.; will take his oath according to the Form subjoined thereto; will grant certificate or debenture of the bounty to which you shall find him entitled, according to Form No. 7; and will then make out a certificate of the whole transaction, according to Form No. 8. The articles shipped, and the quantity of fish cured and landed, you will enter in the usual manner in the Tonnage Bounty Book; will take care, as far as you are able, that the cargo be kept separate and apart from all other fish; will compare the same with the quantity stated in the Journal, noting at the end thereof any differences that may be found, together with such observations on the voyage as may occur to you; and will then transmit the whole of the papers to the Board by the cheapest conveyance that can be found.

Upon

Upon its being signified to you by any person, that he intends to fit out a vessel for the cod and ling fishery, not on the tonnage bounty, you will supply him with a notice, according to Form No. 9.; will grant certificate, according to No. 10. of the articles shipped, or permitted to be shipped; will furnish the master with Form No. 11. of an account to be kept by him, which he will deliver to you, and make oath to before you at the end of the voyage; and you will enter the articles shipped, and the cargo cured and landed, in the usual manner, in the Coast Fishery Book. You will likewise furnish any person intending to cure cod and ling on shore, not caught in vessels of the descriptions before mentioned, with a notice, according to Form No. 12., and with a copy of the account to be kept by him, according to Form No. 13., which, when the curing is completed, you will receive from him, and cause him to make oath to, before you, recording the transactions in the usual manner in a part of the Coast Fishery Book allotted for the purpose. When the fish, in either of the two cases before mentioned, are to be produced for for inspection, you will furnish the curer with a Request Note, according to Form No. 14, and will administer to him the oath subjoined thereto; will compare the quantity so produced with the accounts of cure, noting thereon the differences that may occur; will take care that none of the fish so produced were caught or purchased by vessels on the tonnage bounty; and upon your being satisfied that this is the case, and that the fish are entitled to bounty, you will grant a debenture to each curer, according to Form No. 15, for the quantity so cured by him, and so marked or branded by you. The inspection of the fish, and the debentures granted, will be recorded in the usual manner, in the Bounty Book, of which one part is to be allotted to debentures granted for the tonnage bounty, and another for debentures on fish, cured not on the tonnage bounty.

When a person signifies to you his intention of manufacturing oil from fish taken on the coast of Great Britain, or the Isle of Man, you will furnish him with a Notice, according to Form No. 16, and with a copy of the Account to be kept by him, according to Form No. 17.

You will endeavour to see the oil from time to time, during the process of manufacture; and when it is to be produc-ed for inspection, you will receive from him the account, to the truth of which you will cause him to make oath before you; will furnish him with a Request Note, according to Form No. 18.; will administer to him the oath at the bottom thereof, and then examine the oil; and upon your being satisfied that it has not been previously produced for inspection, and that it is well manufactured, good, free of putrid smell, and in every respect entitled to bounty; you will examine and gauge the casks, to see that they are sufficient, full of oil, and in every respect such as are required by the regulations; and that each barrel, or half barrel, does not contain less than 32 or 16 gallons English wine measure respectively. You will then ascertain the number of tons, and of eighth or sixteenth parts of a ton, to which they amount, allowing 8 barrels or 16 half barrels to each ton; and upon your being satisfied that the oil is well manufactured, good, clear, free from putrid smell, and in every respect en-titled to bounty, you will brand the

easks with your cran iron, and will then grant debenture according to Form No. 19. The notice and account will be entered in a separate part of the Coast Fishery Book; the Request Note, Inspection, and granting of Debenture, in a separate part of the Bounty Book.

The same plan is to be followed with every person intending to manufacture whale bone from the fins of whales taken on the coast of Great Britain, or the Isle of Man. You will supply him with a notice according to Form No. 20, and with a copy of the Account to be kept according to Form No. 21., which are to be recorded in the usual manner in a separate division of the Coast Fishery Book; and when the article is ready to be inspected, you will receive back the Account, which is to be sworn to before you by the manufacturer; will furnish him with a request note according to Form No. 22., and will administer to him the oath at the bottom thereof; will examine and ascertain the quantity of whale bone, by weighing it; and upon your being satisfied that it is perfectly freed from the gum, hair, and all impurities, well scraped, washed, cleaned, and thoroughly dried, and that it is in every respect properly manufactured, fit for market, and entitled to bounty, you will grant debenture according to Form No. 23., recording the inspection, &c. in a separate division of the Bounty Book.

When a person signifies to you his intention of exporting cod, ling, or hake, taken in the British fisheries, you will furnish him with a notice according to Form No. 24.; will examine the fish, take an account thereof, and see them put on board; recording the transaction in the usual manner in the Exportation Book; and you will take particular care to allow the exportation of no cod, ling, or hake, which shall be marked or branded to denote that they have been found entitled to bounty, unless they are really and truly in every respect such as they ought to have been, to entitle them to bounty, when they were originally produced for inspection.

In examining cod, ling, and hake, produced for bounty, whether they have been cured dried, or cured in pickle, you will be particularly attentive to ascertain that they have had the heads

taken

taken off, and been gutted, split up, boned, and cleaned in the manner required by the regulations. You will also take care, as far as possible, that no more of the bone be left in the fish than what is prescribed by the regulations, and that it be neatly taken out; and if the fish are cured dried, that they be perfectly clean, clear in the flesh, freed from the navel, neatly pared, and not mouldy, broken, soft, tainted, dirty, or any ways injured. If they have not been bled immediately after they are caught, the flesh will be dark coloured, and no subsequent care will ever make them clear or white in the flesh. You will also see that the fish are of the length prescribed by the regulations. If you have any doubt on the subject, you will measure them with the handle of the punching iron, which is made exactly 14 inches in length; and you will reject all such as are of smaller dimensions, and as are not in every respect properly cured, sound, and sweet. Great care is also to be taken that the fish neither get too little salt, otherwise they will be tainted; nor too much, otherwise they will be salt burnt.

B

When you are satisfied that the fish cured dried are in every respect such as they ought to be, you will cause each of them to be punched in the tail with a punching iron, formed at the point in the shape of a small square,—thus [], and will then see the fish accurately weighed, keeping a correct account of the number of hundred weights, and granting a debenture accordingly, either as soon after the end of the voyage as the curer may think proper, if the fish have been cured on the tonnage bounty, or at the end of the season; and at all events not above two or three times in the course of the season, if they have been cured otherwise than on the tonnage bounty.

When the fish are produced to you in pickle, you will gauge the barrels, and ascertain that they are of the full size, and in every respect according to the regulations prescribed. You will open such number of them as you may judge necessary, following your practice in this respect in the inspection of herrings. You will reject all barrels that are not conformable to these regulations, or that are not full of fish and pickle, or

in which the fish are not in every respect well cured, sound, sweet, free of taint, or offensive smell, and properly packed. When you are satisfied that the fish and barrels are in every way what they ought to be, you will then brand them with your iron for repacked herrings, and will grant a debenture for them in the manner above mentioned; but if the curer shall have had fish cured dried, as well as fish cured in pickle, marked or branded for bounty, you will, instead of granting a debenture for each kind of fish, include them both in the same debenture.

As cod, ling, and hake may be produced for inspection, either at the place of cure, or at the port of shipment, you are permitted to act in this respect as may be most convenient for yourself, and the general interest of the trade; and as no forfeitures, other than the forfeiture of bounty, are authorized by the act 1 Geo. IV. cap. 103, it behoves you to be doubly careful to guard against imposition, to see that bounty be not improperly obtained, and that fish once branded as having been cured in pickle, shall not be afterwards laid out to dry,

and then be produced again for inspection in that state. You are to keep the punching and branding irons in your own custody, and permit no person to get them into his possession, except when employed and authorized by you to punch fish or brand barrels; and you are not to suffer them to be used for that purpose, but in your own presence, as you will answer to the contrary at your utmost peril.

You will copy these Instructions into your Herring Fishery Order Book, and will in like manner enter your letters and reports on the subject of the cod and ling fishery, in your Herring Fishery
