**REPORT OF THE GOVERNING BODY OF THE INTERNATIONAL INSTITUTE OF INTELLECTUAL CO-OPERATION**

Submitted by Professor G. Oprescu, on behalf of the Governing Body of the International Institute of Intellectual Co-operation, addressed to the Council of the League and to the Government of the French Republic, and communicated to all the Members of the League of Nations.

The Governing Body held its fifteenth session at Geneva on July 15th, 1938, under the Chairmanship of M. Edouard HERRIOT.

There were present at the session the following regular members of the International Committee on Intellectual Co-operation :

1. STATEMENT BY THE DIRECTOR OF THE INSTITUTE ON HIS ADMINISTRATION IN THE INTERVAL BETWEEN THE TWO SESSIONS OF THE GOVERNING BODY

In accordance with the usual practice, the Director of the Institute submitted a general report on the work and administration of the Institute since the last session of the Governing Body.<sup>1</sup>

The following are the chief points brought out in this report :

The Institute continued to work satisfactorily, although difficulties were encountered by the Director on account of increased costs and the resultant unforeseen expenses.

As a whole, however, the administration of the Institute went smoothly, as will be seen later from the particulars of the results of the past financial year and the data relating to the current year. The financial assistance afforded to the Institute by the Rockefeller Foundation to enable it to perform its various secretarial duties in connection with the International Studies Conference was of the greatest value.

## 2. INTERNATIONAL ACT CONCERNING INTELLECTUAL CO-OPERATION

The Governing Body was informed by its Chairman of the action taken by the Government of the French Republic in pursuance of the decision taken by the League Council to entrust that Government with the task of convening at Paris the Diplomatic Conference which is to pronounce on the draft International Act concerning Intellectual Co-operation.

M. E. Herriot explained that the French Ministry for Foreign Affairs had already sent out invitations to all Governments of States Members of the League and to those of non-member States. The date of the Conference has been fixed for November 30th, 1938.

M. E. Herriot was good enough to accept the office of first delegate of France to this Conference.

The French Ministry for Foreign Affairs intends to supplement its invitation to Governments by the despatch of all the texts (reports, memoranda by Governments, proposed amendments, etc.) drawn up for the delegations to the Conference.

M. Herriot referred to the spirit in which the International Committee on Intellectual Co-operation, guided by the recommendations of the second General Conference of National Committees, had drawn up the draft International Act, and made it clear that it was in this spirit that the French Government proposed to organise the Conference so as to ensure its success.

Several members of the Governing Body endorsed the wishes expressed by the Chairman for the success of the proposed Diplomatic Conference.

After taking note of these explanations, the Governing Body considered that, as the question of the International Act has now been submitted to Governments with a view to their participation in a Diplomatic Conference, its rôle would henceforth be confined to holding itself at the disposal of Governments, and particularly of the Government responsible for organising the Conference, with a view to supplying any information it might desire.

With this end in view, the Governing Body approved a proposal to the effect that the Director should be requested to draw up, for the use and guidance of the Conference, a scheme for the administrative re-organisation of the Institute, providing for the revision of the structure of its services in anticipation of new means of action, which will enable certain activities to be further developed, particularly those of its publications and information department.

## 3. FINANCIAL QUESTIONS

As regards financial questions, the Governing Body, in accordance with the usual practice, dealt successively with the three points set forth in the following paragraphs :

(a) With reference to the past year, the Governing Body took note of the report submitted by the League's auditor, which is appended to this document.

The Governing Body noted with satisfaction that the auditor's report showed that the Institute had been excellently administered. Although conditions in general were unfavourable, the year closed with a surplus of 181,962.42 French francs.

The Governing Body was also gratified to note that the statutory Reserve Fund of the Institute, which was re-constituted last year, remains intact.

After approving the Director's proposals concerning the allocation of the profit on the past financial year, the Governing Body authorised him to use it partly for the payment of bonuses to certain of the lower-salaried officials of the Institute, partly to meet the increased cost of upkeep, and partly to extend the publications service.

In this connection, the Governing Body expressed its satisfaction at the very appreciable increase in the sale of the Institute's publications.

The Governing Body concluded its examination by approving the accounts for the past financial year, and endorsing the auditor's proposal to cancel the debts representing certain contributions in arrear from Governments with which it had asked the Director to negotiate for that purpose.

(b) With reference to the current financial year, the Governing Body noted the explanations furnished by the Director regarding the Institute's financial situation, from which it appeared that receipts were coming in normally, and that, in spite of the increased charges due to the general situation, expenditure should not exceed the sums available. The Governing Body was glad to find that the increase in expenditure was accompanied by an increase in receipts, so that the desired equilibrium should presumably not be upset.

(c) As regards the estimates for the next financial year, the Governing Body's chief duty was, as usual, to approve the draft budget submitted by the Director. This draft provides for a total income of 3,242,000 French francs, comprising 2,792,000 French francs of ordinary receipts derived from State grants and 450,000 French francs of miscellaneous receipts.

The Governing Body approved the draft budget as submitted to it, without making any reservations or additions, and was gratified to note that nearly a million French francs was reserved for the preparation and meetings of international committees and for publications.

Special attention was devoted to the very important supplementary funds of the Institute, which have to be taken into account in order to form a general idea of its activities. For instance, as the Secretariat of the International Studies Conference, the Institute receives from the Rockefeller Foundation for various purposes contributions amounting to \$62,500. During the coming year, the Institute will also receive nearly 40,000 pesos from the Argentine and Mexican Governments for the publication of the ethnographical works on the origins of American civilisation.

Special contributions are received for the Ibero-American and Japanese collections, which are published by the Institute.

The Director was therefore able to state that the Institute would actually receive supplementary contributions amounting to approximately 2,000,000 French francs outside its regular budget.

#### 4. ADMINISTRATIVE AND STAFF QUESTIONS

With reference to staff questions, the Governing Body took the following decisions :

It noted the resignation of M. Mohr, principal secretary, and thanked him for the services he had rendered. It also extended the following contracts, which had expired :

M. Belime, principal secretary — contract extended for two years ;

M. Establier, M. Sato, M. Secretan and M. Hickel — contracts renewed for further periods equal in duration to the previous ones ;

M. de Henzel's contract was extended until he reaches the age-limit laid down in the Institute's Statutes.

The Governing Body left it to the Directors' Committee to study the re-organisation of the educational questions service, of which M. Mohr (who has resigned) has hitherto been in charge. In this connection it decided that, in view of the valuable services he had rendered, M. Mercier should be appointed head of this service, under the conditions to be determined by the Directors' Committee.

This reorganisation will entail the engagement of a new official to assist M. Mercier. On the Director's proposal, the Governing Body selected M. O. P. Grunt, a Norwegian, who has an expert knowledge of educational questions.

#### 5. ALLOCATION OF THE SUMS RECEIVED FROM THE GENERAL COMMISSARIAT OF THE PARIS EXHIBITION

The agenda of the Governing Body included the question of the allocation of the sums granted as a contribution to the "Intellectual Co-operation Month" by the General Commissariat of the Paris Exhibition. These sums amounted to a total of 190,000 French francs.

The Governing Body left it to the Director of the Institute to consult the General Commissariat of the Exhibition as to the manner in which these sums should be appropriated, so as to conform to previous practice. At its next session, the Directors' Committee of the Institute, acting in the light of the information obtained by the Director, will finally decide upon these appropriations, and will transmit them to the proper quarters with a view to a final settlement.

#### 6. MISCELLANEOUS QUESTIONS

The Governing Body was called upon to pronounce on a request by the *Fédération internationale des Cinémathèques* for accommodation on the Institute's premises.

The Governing Body decided to accede to this request in principle, while affirming its general desire not to increase the number of associations already accommodated.

In the light of the opinion expressed by the Directors' Committee, the Governing Body declined the proposal that the Institute should be entrusted with the publication of a biographical collection of contemporary artists.

#### 7. GOVERNMENT DELEGATES TO THE INSTITUTE

The Governing Body renewed the tribute already paid at previous sessions to the valuable work done by Government delegates to the Institute. The assistance of these forty-one delegates is of the greatest help to the Institute. In thanking them, the Governing Body expressed the hope that this assistance would be continued, and, if possible, increased.

AUDIT OF THE ACCOUNTS OF THE INTERNATIONAL INSTITUTE  
OF INTELLECTUAL CO-OPERATION FOR THE FINANCIAL YEAR 1937

REPORT BY M. U. A. J. BRUNSKOG

I have examined in detail the accounts of the International Institute of Intellectual Co-operation and have found them in order. I have also the honour to submit the following observations :

I. EXECUTION OF THE BUDGET FOR THE FINANCIAL YEAR 1937

It will be seen from Table A that the surplus is due mainly to contributions received in respect of the year 1936, which of course were not included in receipts for the budgetary year 1937.

As regards receipts, the percentage of contributions actually received, as compared with contributions due for the financial year, increased to 99.67, a figure which is misleading, however, unless allowance is made for foreign exchange profits in the payment of contributions. It might be advisable to include in the budget a special item showing gains and losses on foreign exchange.

As regards arrears of contributions, reference may be made to the figures shown in Table C. Since some of these debts are clearly unlikely to be paid, as they are of long standing or for some other particular reason, it would seem advisable to write them off. To do so, however, would necessitate a decision by the Governing Body.

II. ADMINISTRATION OF THE VARIOUS EXTRA-BUDGETARY FUNDS

Apart from budgetary receipts and expenditure, the Institute also has receipts and expenditure in respect of extra-budgetary funds. For an account of these, see Table D.

Item A, 1 of that table comprises "Publication of the Collection of Latin-American Classics", which, in accordance with the decision of the competent authorities, has to be subdivided into as many accounts as there are contributions. The following particulars are given :
