PREFATORY NOTICE.

We think it may be well to state here the reasons why the genealogical outlines of the families of Douglas of Mulderg and Robertson of Kindeace have been printed. They are the work of a descendant of the Douglas family, who lives amongst us, and has been known during the last thirty or forty years as a genealogist of great ability and possessing very wide information. This gentleman has frequently of late years been asked for information regarding these two families, therefore he has kindly complied with the request of some of those interested in the Douglas and Robertson families that his genealogical knowledge of them should be printed. The advantage of printing will be seen when it is understood that a large portion of the matter this book contains has not hitherto been published, and might easily be lost and forgotten, as many of the descendants of these families have not been proprietors of land and their representatives have gone to all quarters of the globe in order to make their fortunes. The habit of wandering far afield has rendered the collection of full particulars in some cases extremely difficult, and in others impossible; so, when there are errors in this book, they may, we hope, be pardoned, as great eare has been taken in trying to avoid mistakes.

It is with considerable regret that the system of giving authorities for every sentence and word has been abandoned; but, if this plan is properly carried out, it increases the bulk of a book to a tremendous extent, and, owing to the long quotations necessary, renders a genealogy rather broken; also, if the system of giving authorities is not scrupulously adhered to, it leaves as much room for romance and false statements as there would be if no authorities were given. However, most of the quotations from documents and sasines in these two genealogies were kindly given by Sir James D. Mackenzie, Bart. of Scatwell and Tarbat, from the genealogical papers of his late brother, Lewis M. Mackenzie, Esq. of Findon; as well as by Charles Fraser-Mackintosh, Esq. of Drummond, who has most courteousity allowed information to be reprinted from his valuable, and now scarce, work, "The Antiquarian Notes," which contains so much matter relating to the Robertsons of Inches and their descendants.

Much information has also been gathered from such books as Dr Hew Scot's important collection of particulars concerning Scotch ministers, the "Fasti Ecc. Seo.," as well as "The Origines Parochiales Scotia," "Northern Notes and Queries," and many other works of an historical character. Also contemporary MSS., and other sources, from which genealogical matter can be obtained, have been searched.

Regarding the origin of the Clan Robertson, nothing has been said, as it has been considered better to begin that genealogy from a distinct and clear ancestor, rather than to try and find the name of their progenitor through a mist of years, which has allowed even great authorities to arrange the Robertson origin according to fancy, and to carry them down, unsupported by contemporary evidence, until a firm foothold could be found. The remote origins, through a string of names, given to Clans may be pleasing to some people on account of great antiquity, but to those who think about genealogies these wild flights of speculation or romance make a work absurd, and cast suspicion and doubt on the portions treating of a

later date, which are probably really honest and worthy of credence.

THE DOUGLASSES OF MULDERG.

THE exact date at which the Douglasses settled in Ross-shire cannot now with accuracy be ascertained. But the traditions of the family uniformly assert that they came from Lanarkshire to the North about the time of the Reformation.

It appears from reliable evidence that they were located about the Abbey of Fearn, in Easter Ross, at the latter part of the sixteenth century, and possessed landed property in the seventeenth and early part of the eighteenth century, in the

parishes of Fearn and of Kiltearn.

In the Valuation Roll, 1644, of the Sheriffdom of Inverness, including Ross, Hector Douglas I. of Mulderg is styled "of Mulderg;" his rental in Fearn parish is marked £1540 Scots, and in Kiltearn parish £533 6s 8d Scots. In 1646 he was one of those selected to make a loan, his name and the amount appearing in a list discerned at Aberdeen thus—"Hector Douglas,

Elder of Mulderg, £1333 6s 8d Scots."

Hector Douglas IV. of Mulderg was appointed one of the Commissioners of Supply for the Sheriffdom of Ross in 1661. In 1662 he was fined £2400 for non-conformity to Scottish Episcopacy, the highest fine being that of Mackenzie, Kilcoy, £6000, who is said to have been a pious man. The second largest was that of the excellent Sir Robert Munro, Baronet of Fowlis, £3600. The third highest was that of Hector Douglas, Mulderg. He was in good company, for Wodrow, the historian, testifies relative to those who were fined, "that so far as he could learn anything about them, generally speaking, they were persons of the best morals and most shining piety in the places where they lived, and chargeable with nothing but being Pres-

byterians. Middleton thought that all the fines would have come into his own hands, as well as the estate of the Marquis of Argyle; but of all this he was disappointed, as the money came to other hands. But the fines were uplifted and much more by military force" (see Wodrow's History, vol. I., page 271).

From the title deeds of the property of Mulderg in the possession of the present proprietor, it appears that there was a "Hector Douglas, younger," in 1647; also that a "Hector Douglas died in 1675." The Douglas family ceased as proprietors of Mulderg in 1718. Some of the Douglasses also possessed the estate of Rainy, which adjoins that of Mulderg to the north and north-east. Both these properties were possessed by the Maccullochs at a later date.

The Douglasses of Mulderg and of Kiltearn were the same family, and their burying-grounds in both parishes can be pointed out.

Below is a copy of the initials in the burying-ground of the Douglasses in the aisle adjoining the Abbey of Fearn at the north-east.

As far as can be discovered the "I" here signifies interred.

The burying-ground of the Douglasses in Kiltearn is at the east gable of the Parish Church, surrounded by a high iron railing attached to the gable of the Church, and several tombstones on pillars along the gable within the railing.

DESCENT OF THE DOUGLAS FAMILY.

- I. HECTOR DOUGLAS I. of Mulderg was proprietor as early as 1630, for his son Hector was then "apparent of Mulderg." According to "Northern Notes and Queries," Hector the elder married Janet Ross, but it is more likely his wife was H. Ross—see the initials on the Douglas tomb at Fearn, where he and his wife are buried. He was living 1647, but died before September, 1653, leaving issue:—
 - 1. Hector, his successor, of whom below as II. of Mulderg.
- 2. Agnes, married to the Rev. Thomas Mackenzie III. of Inverlael, parish of Lochbroom, Archdean of Ross. They had sasine of lands in Kincardine, 28th June, 1641; and she had sasine of lands of Cadboll, 26th January, 1653, and was still living in 1669. The Rev. Thomas Mackenzie, who died 7th April, 1665, and was buried at Fearn, had been admitted minister of Tarbat, 1633, but he deserted his charge in 1635, and went to Ireland, from whence he returned and took up his residence in Ross-shire, being admitted at Killearnan prior to 2nd November, 1638. He was second son and eventually heir of the Rev. John Mackenzie I. of Inverlael, Archdean of Ross, who purchased the estate of Inverled from Lord Lovat in 1610, having married, 31st May, 1606, Margaret or Janet Innes, daughter and co-heir of William Innes of Calrossie, and grand-daughter of Walter Innes of Calrossie, and his wife Margaret, daughter of Lauchlan Mackintosh of Mackintosh (who was murdered by some of his clan, 1524) by his wife Jean, only daughter of Alexander Gordon of Lochinver. The Laird of Inverleel and Agnes Douglas had issue—(1) John IV. of Inverlael, who married a daughter of Ross of Balnagown, 1670; (2) Thomas, W.S., died unmarried; (3) a daughter, according to tradition the wife of Hector Douglas V. of Mulderg; (4) a daughter, second wife of Sir Kenneth Mackenzie, 1st Baronet of Coul, had issue.

3. Isabella, married (contract dated 11th November, 1639), as his second wife, to Mr William Ross V. of Shandwick, who died 20th April, 1663, by whom she had three daughters. Isabella Douglas married, secondly, Andrew Fearn, portioner of Pitcullen.

II. HECTOR DOUGLAS II. of Mulderg married, about 12th August, 1630, Bessie Gray, eldest daughter of George Gray of Skibo, Sheriff-Depute of Sutherland. On 6th September, 1653, "Hector Douglas" was retoured "heir of his father, Hector Douglas of Mulderg." He died before 9th July, 1656, and Bessie Gray married, secondly, Andrew Ross, Provost of Tain, who died before 8th August, 1668. She was living 4th March, 1670, for she was then liferentrix of Mulderg. Hector Douglas and Bessie Gray had issue—(1) Robert Douglas, of whom below as III. of Mulderg; (2) Hector Douglas, of whom below as IV. of Mulderg; (3) a son, — Douglas, who married and had issue a son, Hector Douglas V. of Mulderg, successor to his uncle, Hector Douglas IV. of Mulderg in 1676.

III. ROBERT DOUGLAS III. of Mulderg (son of Hector Douglas and Bessie Gray) succeeded in or before 1656, and married Jane, daughter of the Honourable Simon Mackenzie of Lochslin, son of Kenneth the first Lord Kintail. Marriage contract dated 9th July, 1656, "between Robert Douglas of Mulderg, eldest lawful son to deceased Hector Douglas and Jean, eldest lawful daughter to Simon, brother german to George, Earl of Seaforth." Robert Douglas died before 1661, and Jean Mackenzie, his widow, married, secondly, Sir James Grant of Moyness, in Nairnshire. She died in 1707. Robert Douglas having no male

issue the estate passed to his brother.

IV. Hector Douglas IV. of Mulderg (son of Hector II. of Mulderg and Bessie Gray), who married Margaret, eldest daughter of David Ross III. of Pitcalnie by his wife Margaret, second daughter of Alexander Mackenzie of Kilcoy. Sasine on marriage contract of Hector and Margaret 4th March, 1670. Hector Douglas IV. of Mulderg died about 1675, and was buried

at Fearn. He having no male issue was succeeded by his

nephew.

- V. Hector Douglas V. of Mulderg, son of —— Douglas and grandson of Hector II. of Mulderg and Bessie Gray. On the 4th April, 1676, "Hector Douglas of Mulderg" was retoured "heir of Hector Douglas of Mulderg, his uncle on the father's side." He married his first cousin once removed, a daughter of the Rev. Thomas Mackenzie III. of Inverlael, by whom he had issue—
- 1. Hector Douglas VI. of Mulderg, Sergeant in the 3rd Regiment of Foot Guards. He sold some lands to the Maccullochs in 1718.
- 2. Robert Douglas, Ketwell, in Kiltearn. He was twice married, and had issue by both wives. See under the heading "The Descendants of Robert Douglas."

3. Christian Douglas, married to George Robertson in Balcony, and had issue. See under the heading "The Descend-

ants of Christian Douglas."

4. Flora Douglas, married to William Aird, farmer, Wester Kincraig, and had issue. See under the heading "The Descendants of Flora Douglas."

THE DESCENDANTS OF ROBERT DOUGLAS.

ROBERT DOUGLAS, in Ketwell, parish of Kiltearn (son of Hector Douglas V. of Mulderg), was an elder in that parish about 1728. He married twice. Firstly, Ann, fourth daughter and co-heir of John Munro, proprietor of Tirivan in Kiltearn, now in the farm of Culrain, on the Novar estate (sister of Mrs Captain George Munro of Culcairn). Issue—

I. Captain William Douglas, of the Marines. He resided at Fyrish, parish of Alness, and married at Ardullie, 14th October, 1766, Jane, daughter of the Rev. John Bayne, of the Baynes of Tulloch, first Presbyterian minister of Dingwall after the

Revolution. Issue—Robert, who died in Demerara.

II. Elizabeth (daughter of Robert Douglas in Ketwell) born November, 1703, of whom nothing more is known.

III. Flora, married Mr Forrester, parish of Cromarty.

ROBERT DOUGLAS, in Ketwell, married, secondly, Catherine, daughter of Munro of Tighnaird, in Kiltearn. She was very distinguished for piety. Issue—

I. Lieutenant Farquhar Douglas married, 1st July, 1765, Jane, third daughter of Hugh Munro, Clayside, parish of Golspie, and sister of Sir Hector Munro of Novar, Knight. No issue.

II. John Douglas married Girzell, daughter of John Mackenzie, farmer, Achoyle, parish of Kilmuir-Easter, by his wife, Girzell Crommie, who was distinguished for her piety, and was descended from Roa, the Reformer and coadjutor of Knox, in preparing the Scottish Confession of Faith and First Book of Discipline and in carrying on the Reformation in Scotland. Issue—an only daughter whose descendants are in America.

III. Robert Douglas, farmer of Balcony, parish of Kiltearn (son of Robert Douglas in Ketwell), married Janet, daughter of Hugh Robertson, senior, farmer, Balcony, and sister of Hugh

Robertson, junior, farmer, Balcony. Issue—

1. George Douglas, minister successively of Kirkwall and of Tain from 1769 to 1794. He married, 9th February, 1779, Anabella S. Munro, daughter of the Rev. Joseph Munro, minister of Edderton, son of Robert Munro, minister of Kincardine. George Douglas was distinguished for personal piety, fervour in prayer, and evangelical sentiments, which he delivered in a chaste and beautiful style. Issue—

(1). Margaret, died unmarried.

(2). Mary, died unmarried, 9th May, 1864.

(3). Anabella, died unmarried, 1875.

(4). Jessie, died unmarried.

(5). Barbara, died unmarried, 1851.

(6). Elizabeth, married, 1802, Julian Labalmondiere, Esq., of London, who died 1823. She died 1866, having had issue

(with others) the late Lieutenant-Colonel Labalmondiere, C.B., Assistant Commissioner, Metropolitan Police, who married and had issue.

(7). Joseph, died 1849. He was a barrister in London.

- (8). Robert Douglas (son of the Rev. George Douglas) married Mary Caird, died 1825. Issue—(1a) Anabella Stuart Agnes, married, 1864, to James Brodie, D.A.C.S., Edinburgh. She died 1875. (2a) Robert Douglas, of Douglas Park, Glasgow, married, in 1858, Mary Ann, daughter of the Rev. Stephen Butler, of Trinity Church, Southampton. Issue—(1b) Mary Giulton, born 1860; (2b) Robert Lushington, died unmarried 1888. (3a) Mary, married, 1846, to Kenneth Mackenzie Adams, M.D., born 1819, died 1856. She died September, 1892. Issue—(1b) Kenneth Douglas Adams, born 1848, married Margaret Alice Dunn; (2b) Mary Jane Adams, married Alfred Hutcheson, who died 1876, by whom she had issue Kenneth Douglas Hutcheson, born 1875; (3b) Robert Frederick Douglas Adams, surgeon, born 1855.
- 2. Gilbert Douglas, Esquire (son of Robert Douglas, Balcony) of Douglas Park, Lanarkshire, married Cecilia Douglas of Glasgow, sister of Sir Neil Douglas, Commander of the Forces in Scotland. She was in her day the toast of Glasgow. He died 1807. She died without issue 1863, aged 89.
- 3. Jannet Douglas married William Munro, of the 42nd Regiment, a cadet of the Lealty family, parish of Alness. He was tacksman of Ketwell, and died April, 1786, aged 63. She died at Ardullie, parish of Kiltearn, 3rd March, 1831, in her 80th year. She was distinguished for personal godliness and living a life of prayer. Issue—
 - (1). A daughter, who died in infancy.
 - (2). Robert, died abroad.(3). George, died abroad.
 - (4). Gilbert, died in England.

(5). William, married an English lady, and left issue—Colonel William Munro, in the 39th Regiment, and three other sons, two of whom were in the army, and eight daughters, some married and some unmarried.

(6). Esther, married her cousin, Mr Alexander Sutherland, Ardullie. Issue—(1a) Cecilia, died unmarried; (2a) Robert, died in Australia, 1862; (3a) Jessie, married Mr Hector Sutherland, late banker, Beauly, and had children. Mr Alexander Sutherland died 30th April, 1829, in his 60th year. His widow died 27th June, 1850, aged 82.

4. Margaret Douglas (the eldest daughter of Robert Douglas, Balcony) married Captain Robert Munro of Achinduich, parish of Creich (second son of William Munro III. of Achannie, by his wife, Isabella Macpherson; they were married in 1714). Issue—

(1). John, killed by a tiger in India.

(2). Hectorina, married Gilbert Mackenzie, Invershin. died at Tain, 24th July, 1836; and his widow died there, 13th May, 1846. Issue—(1a) Robert, born 14th May, 1784, died 1791. (2a) Christy, born 14th December, 1785, married, firstly, — Macdonald. Issue, none surviving. She married, secondly, George Cameron, Sheriff-Substitute of Ross-shire, but had no surviving issue by him. (3a) Donald, born 9th April, 1783, died 1838. He was a Captain in the 42nd Regiment; married Mary Issue—(1b) Robert, Captain in the army, died unmarried. (2b) Eliza, married Mr Smeaton. Issue—(1c) Donald Mackenzie, Bengal Civil Service, married a daughter of Mr Henry Lushington, Bengal C.S., son of Sir Henry Lushington. Issue—Mary and Arthur. (2c) Robert, Bengal C.S., a member of Legislative Council and LL.D. of St Andrews. (3c) Agnes, married Dr Wilson. No issue. (4c) Charlotte, married General H. Hastings Fraser, Madras Army, and of Ardochy, Inverness-shire, as his second wife, and had issue—David and Dr Arch. Fraser. (5c)Charles Oswald, Captain, Bengal Royal Artillery. (3b) Marion, second daughter of Captain Donald Mackenzie, married John

Allison, Esq., merchant, Leith. Issue—(1c) Mary; (2c) Tiny, married Mr Jackson, a barrister in London. Issue—a son and a daughter. (3c) John. (4b) John Robertson, married Lizzie Issue — Charles, Lieutenant, Staff Corps. William, born 1791, was Brevet-Captain in the 1st Royals; died unmarried in 1829. (5a) Robert, born 1793, died 1819, Lieutenant in the 60th Regiment Canadian Rifles, died unmarried. George, born 1769, died unmarried in Demerara 1823. John, born 14th March, 1799, died 1854, was a planter in British Guiana, married Isabella Munro 17th October, 1846. Issue—(1b) Gilbert Proby, born 15th August, 1847, Surgeon-Major, Bengal Medical Service, married Jane Scott. Issue— (1c) John Scott; (2c) Thomas Rennie; (3c) George Kenneth; (4c) Isabella; (5c) Emma; (6c) Gilbert Proby, who died March, 1890. (2b) Donald George, born 29th May, 1849, died 6th July, 1885. He was Captain in the 2nd Regiment of Scind Horse; married Mary Ruth Prior, daughter of Captain Prior, R.A. Issue—(1c) Isabella H. Ruth; (2c) Ethel Lucy; (3c) Charles Tindal Grant, born 24th May, 1852, died 1st October, 1852. (8a) Bell, born 1804, married Mr Ross, died 1834, having had issue—(1b) Williamina; (2b) George; (3b) Donald.

(3). Janet, daughter of Captain Robert Munro of Achin-

duich, married Mr John Mackay, Rogart. No issue.

(4). Isabella, married Mr Campbell. Issue—a daughter,

who went to America.

5. Ann Douglas (daughter of Robert Douglas, Balcony) married Mr John Ross, Tain, descendant of Ross of Achnadoich, a near relative of Ross of Shandwick, had a large family of sons and daughters, whose descendants are now gone, with the exception of those of

(1). Janet Ross, married Thomas Rattray, a Brazilian merchant. Issue—(1a) Agnes Mary, married Captain Andrew Smith, R.N. Issue—(1b) Andrew William Smith, Colonel,

Royal Marines, married Myra Elizabeth Laxmoore. Issue—(1c) William Douglas, Lieutenant, Royal Scots Fusiliers; (2c) Piercy Douglas; (3c) Florence Douglas; (4c) Kate Laura Douglas. (2b) Jessie Douglas, daughter of Captain Andrew Smith, married Robert Beith, M.D., R.N., Deputy Inspector General of Hospitals and Fleets. Issue—(1c) Robert Douglas, Lieutenant, Royal Marines; (2c) James Brooke; (3c) Clara Annie; (4c) Agnes Maria Jessie. (2a) Annie Helen Rattray, daughter of Thomas Rattray,

married James Neilson, S.S.C. No issue.

(2). Cecilia Ross, married to John Munro, J.P., factor of Fowlis. Issue — (1a) William, of Marchbank, Midlothian married, firstly, Elizabeth Annie Brown, by whom he had issue —(1b) Charles Douglas, died 1889. (2b) John Culcairn, who has succeeded to one-half of the estate of Orbiston, Bothwell, bequeathed to him by his kinsman, Robert Douglas. (3b) Cecilia Ross, married to William Traquair, W.S. Issue— Winefred. William Munro married, secondly, Katherine Emma Biscoe, eldest daughter of Thomas Porter Biscoe of Newton and Kingellie, county Inverness. No issue. (2a) The Rev. George Douglas R. Munro, minister successively of the Free Church, Loggie Rait, Perthshire, and of Jordan Hill, Glasgow, married Mary Helen Reach. Issue—Ian and Cecilia. (3a) Seymour Hugh, M.D., Nantwich, married Mary Meikle. Issue---(1b)John Douglas R. Munro, M.D.; (2b) Robert; (3b) Harry; (4b) George; (5b) Ronald; (6b) Margaret. (4a) Cecilia, married Mr George Middleton, Carnton, Ferintosh. Issue—(1b) George; (2b) John; (3b) Thomas. (5a) Jessie Esther, married the Rev. Malcom Macgregor, Ferintosh. Issue—(16) Malcom Secundus; (2b) John William.

IV. Duncan Douglas, Tinaird (son of Robert Douglas, Ketwell), of the Custom House, Inverness, married Ann, daughter of James Robertson, farmer, Culcairn, brother of the Rev. Gilbert Robertson, Kincardine, and had several sons and daughters.

Their only descendants left in 1865 were their grandchildren, Johanna and Jane Mackenzie, in Dingwall.

V. Ann Douglas, married Mr Hugh Robertson, junior,

Balcony, parish of Kiltearn. Issue—

1. Janet Robertson, married Mr John Ross, farmer, Cadboll. Issue—



- 2. Catherine Robertson, married Mr Robert Sutherland, Wester Fowlis. Issue—(1a) Alexander Sutherland, Ardullie, who married his cousin Esther, daughter of William Munro and Janet Douglas.

THE DESCENDANTS OF CHRISTIAN DOUGLAS.

Christian Douglas (daughter of Hector Douglas V. of Mulderg) married, before 1699, George Robertson, in Balcony, farmer, parish of Kiltearn. George Robertson was descended from the Plantagenets, Bruces, and Stewarts, as follows:—



George Robertson and Christian Douglas had issue—

He was appointed catechist in the parish of Contin, 31st August, 1726, which he resigned 6th September following, and became tutor to Sir Harry Munro of Fowlis, whom he accompanied to the Academy of the celebrated Rev. Dr Philip Doddridge of Northampton and studied Divinity under him, and was licensed to preach the Gospel 22nd August, 1737, and ordained 7th June, 1739, The account of the Munros of Fowlis appended to Dr Doddridge's life of Colonel Gardener was supplied to him by Mr Gilbert Robertson. After a petition from the whole parish of Kincardine, county Ross, on the 7th April, 1742, Mr Robertson was presented by George, Earl of Cromarty, 10th July and admitted 31st August, 1742, minister of that parish, The Rev. Gilbert Robertson married, 13th October, 1747, Christian, eldest daughter and co-heir of the Rev. John Bayne, minister of Dingwall, by his wife Ann, daughter of Peter Bethune of Culniskea and Jean, eldest daughter of Sir John Munro of Fowlis, 4th Baronet, "The Presbyterian Mortar-piece." Mr Bayne was first Presbyterian minister of Dingwall after the Revolution from 1716 to 1737. Mrs Robertson died young about 1764. He must have been a man of ability when he acquired the knowledge of it which he did, for at that time no Grammar or Dictionary of the language was available. But his own congregation understood him well. The Rev. Mr Sage of Resolis, who knew Mr Rainy intimately, says of him in his Memorabilia that he "was a very model of a sincere practical Christian, and preached the Gospel by his life; that when his congregation connected the doctrine which he taught in the pulpit with his intercourse amongst them, his sanctified dispositions and warmth of heart, they forgot the liberties which he took with their language and listened with attention, because they were convinced that they heard the Truth from the lips of one of its most faithful ministers." Captain Robert Gordon was the only son of Robert Gordon, Rhein, parish of Rogart, by his first wife Barbara, daughter of Robert Munro of Blairich, second son of Hugh Munro II. of Achannie. Barbara Rainy died in 1854. Harry Rainy died in Glasgow 1876. Issue—(1a) Anne Rainy, born at Glasgow 17th October, 1820, married by the Rev. Dr Thomas Brown to John Mackintosh Balfour, W.S., of Pilrig, eldest son of James Balfour of Pilrig. He succeeded to Pilrig on the death of his father in 1860, and to the entailed estate of Strathkinnes, in Fife, in 1883, on the death of John Whyte Melville, when he assumed the additional surname of Melville. Mrs Balfour-Melville died 17th December, 1891. Issue—(1b) Annie Mackintosh Balfour, born at Glasgow 6th March, 1845, married at Pilrig by the Rev. J. C. Macphail to Charles Alexander Cuningham of the Bombay Staff Corps (Jacob's Rifles), son of Alexander Cuningham, W.S., Edinburgh. They were married 23rd November, 1869, and were stationed at Kurrachee, Scinde, C. A. Cuningham being attached successively to the 1st and 2nd Balooch Regiments. He became Captain 1870, and Major in 1878. Annie Mackintosh Cuningham died at Kurrachee 25th January, 1881, and had issue, all born at Kurrachee, viz.— (1c) Anne Caroline (Aline), born 1st January, 1871, married in 1892 to Horace H. Flora Douglas (daughter of Hector Douglas, V. of Mulderg) was married to William Aird, farmer, Wester Kincraig, parish of Rosskeen (this marriage must have taken place before

1700). They had issue—

He was in Captain George Munro of Culcairn's Company in the Black Watch (now the 42nd Regiment) when Captain Munro was killed at Locharkaig in August, 1746. died in 1823, much past 80 years of age.

II. John Aird, married, firstly, his cousin, Janet Robertson, daughter of George Robertson, Balcony, and of his wife, Christian

2. Elizabeth Aird, married Alexander Munro, Drummond. John Aird married, secondly, Catherine Ross, sister of

Donald Ross, farmer, Nonekiln, parish of Rosskeen. Issue—
1. Anne Aird, married to Donald Kemp, Park and Sowardale, in Kiltearn parish. Issue—(1a) George Kemp; (2a) David Kemp; (3a) Donald Kemp, in Clair, parish of Kiltearn.

2. George Aird, died abroad.

3. Twins Donald Aird, died 1853, aged about 90, having married and left issue, who emigrated.

4. Flora Aird, died unmarried.5. David Aird, died unmarried.

John Aird was in Lord Loudon's Regiment in 1745-6. He had a farm at one time in the east end of the parish of Creich, and then in Newmore, parish of Rosskeen, where he died in 1788, very aged. John Aird and his brother George were with their parents in the Church of Nonekiln, parish of Rosskeen, when it fell in 1714 during Divine service, but they escaped uninjured.

III. William Aird (son of William Aird and Flora Douglas) had the farm of Torran, and afterwards of Heathfield, in the parish of Kilmuir-Easter. He married Elizabeth Munro, daughter of William Munro, farmer, Invergordon, and his wife, Janet Squair. William Aird died in January, 1797, aged 82. Issue—

1. Janet Aird, married to —— Rose, teacher in Ardclack,

and had issue.

2. Flora Aird, married Donald Murray, farmer, Tuchendown, parish of Rosskeen. They left issue who emigrated. She died about 1833, aged 80.

3. Rebeka Aird, married to George Graham, Invergordon, and had issue who emigrated.

4. Mary Aird, died unmarried about 1826, aged 82.

5. Gustavus Aird, J.P., born 6th May, 1752, married 24th June, 1797, Ann, eldest daughter of John Grant, farmer of Polnical, parish of Kilmuir-Easter, by his wife Margaret, daughter of the Rev. George Grant, minister of Kirkmichael, county Banff, from 1725 to 1772. Margaret Grant's mother was Ann, daughter of the Rev. James Chapman, minister successively of Cawdor and of Cromdale from 1699 to 1737, by Ann, daughter of Cuthbert of Castlehill, who fought under Gustavus Adolphus, and was present at the battle of Lutzen in 1633. John Grant, farmer of Polnical, was son of Gregor Grant, farmer of Polnical, and grandson of William Grant of Ardoch, now called Pointzfield, parish of Resolis, by his second wife, Kate Mackenzie. contract of marriage of William Grant of Ardoch and Kate Mackenzie was dated 23rd November, 1680. She was daughter of Colin Mackenzie, II. of Kincraig (who married Agnes, daughter of Duncan Bayne of Delny), and grand-daughter of Colin Mackenzie, I. of Kincraig. William Grant of Ardoch was son of John Grant of Moyness, and grandson of James Grant of Logie, sometimes called of Ardneidlie and of Edenhill (who died before 1623), and his wife Katherine, daughter of William Rose of Kilravock. James Grant of Logie was a younger son of Duncan Grant of Freuchie, or Grant, and grandson of John Grant of Freuchie, or Grant, and his wife, Lady Marjory Stewart, daughter of John, 3rd Earl of Athol, and grand-daughter of John, 2nd Earl of Athol, and Lady Mary Campbell. Gustavus Aird died at Heathfield 13th May, 1835. Ann Grant (Mrs G. Aird) died 24th March, 1859, aged 88. Issue—

(1) Elizabeth Aird, born 13th April, 1798, died in Tain, 11th February, 1843, married 23rd December, 1831, to George Murray, merchant, Tain, who died 11th February, 1879, aged 81.

Issue—(1a) Sarah Robertson Murray, born 11th November, 1832, married 6th October, 1857, to Alexander Campbell, of Sidney, N.S. Wales. She died in Sidney, in February, 1871, having had issue—(1b) Gerald Ross Campbell, born July, 1858; (2b) Murray Aird, born November, 1860; (3b) Constance Leila, born 1863; (4b) Gordon Huntly, born 1865; (5b) Florence Ida, born 1867; (6b) Laura, born 1868. (2a) Gustavus Aird Murray, born 14th October, 1833, and baptized by the Rev. Dr Macdonald, Ferintosh, married in New South Wales, 21st January, 1865, Mary Elizabeth Capp. Issue—(1b) George Hugh Murray, born 13th November, 1865; (2b) Annie Capp, born 17th November, 1867, married 9th May, 1893, to Andrew Essex Scott Walgett; (3b) Minnie Augusta, born 17th January, 1871; (4b) Mary Dora, born 17th August, 1872; (5b) Charles Gustavus, born 6th December, 1873; (6b) Eva Campbell, born 25th October, 1875; (7b) Murray Gustavus Aird, born 7th April, 1879. (3a) Robert Murray, died in infancy in 1835. Williamina Johannah Hughina Murray, born 27th June, 1837. (5a) Ann Murray, died in infancy. (6a) Elizabeth Murray, born 11th April, 1839. (7a) Georgina Murray, born 11th February. 1843, married 18th August, 1868, to James Vass, M.D., Provost of Tain. Issue—(1b) Nicholas Vass, born October, 1873.

Creich by the same Presbytery, 27th January, 1841; translated and admitted minister of the Free Church congregation of Creich, Sutherlandshire, by the F.C. Presbytery of Dornoch, 16th August, 1861; married 16th January, 1861, Mary, fourth daughter of William Sim, Esq., J.P., Scotsburn. The Rev. G. Aird had the Degree of D.D. conferred on him by the University of Aberdeen in March, 1885, and was Moderator of the Free Church in 1888.

The Arms, Crest, and Motto, borne by the family of Douglas of Mulderg and Kiltearn.

ARMS:—Argent, a human heart, Gules, imperially crowned Proper, on a chief, Azure, three mullets of the field.

CREST:—A human heart, Gules, ensigned with an imperial crown, between two doves' wings, Proper.

Motto:—Forward.

THE ROBERTSONS OF KINDEACE,

THE name by which the Robertsons are known is "Clandonachaidh." Their genealogy cannot be commenced prior to the time of Andrew de Atholia, who was father of Duncan DE ATHOLIA. EARL OF ATHOL from whom the Clan takes its name. He was a great warrior, and a firm supporter of the cause of Robert Bruce. When a very aged man he fought, in company with his son Robert, at the battle of Durham against the English, 12th October, 1346. He married a daughter of Callum Ruaidh Leamnach (the Gaelie name of Malcolm, 5th Earl of Lennox), by whom he had a son and successor, Robert. Duncan de Atholia married, secondly, one of the co-heirs of Ewen de Insulis, Thane of Glentilt, by whom he had issue—Patrick, progenitor of the Robertsons of Lude, Thomas, and Gibbon. He had a Charter, dated December, 1355, from John, Bishop of Dunkeld— "Nobili viro Duncano, filio Andree de Atholia, et heredibus suis masculis terrarum de Adulia;" and dying soon afterwards was succeeded by his eldest son,

ROBERT DE ATHOLIA, Bailie of the Earldom of Athol. He appears in the Chamberlain Rolls of Scotland, 1358, thus—"Et nihil hic de exitibus Curiae vice comitatus, pro tempore computationis quod cecidit, nisi de hiis, de quibus extitit, deforciamentum per Robertum, filium Dumcani, filium Andree de Atholia, super quod consulatur Rex." He married, firstly, one of the co-heirs of Sir John de Striveling of Glenesk, and had by her an only daughter, Jean, married to Alexander de Meyners of Fothergill.

He married, secondly, it has been stated, one of the co-heirs of Ferdill, situated in the Stormont, in Perthshire. He undoubtedly acquired one half of the lands of Ferdill, as there is a Crown Charter for them—thus: "Carta Roberti fil. Duncani de Atholia," &c., &c.—in the Printed Record of the Great Seal, page 28, No. 42, dated 24th May, 1363. He was succeeded by his

son by the second wife, viz.,

Duncan (Crosda) de Atholia, who appears in the Rotuli Scotiae, Vol. II., page 277, where he is designed as "Duncanus de Atholia, dominus de Rannoch." He was a hostage in England for the ransom of King James I., and is mentioned in the same way as above in the year 1432, in Rymers Foedera, Vol. IV., part 4, page 180. When a man of advanced years he granted, on 20th January, 1438, a charter for some lands to the Dean of Dunkeld, in which he was called "Dominus de Strowan." He married (according to Douglas's "Baronage of Scotland" a lady of the name of Graham) and died leaving issue, Robert, a very celebrated chief, progenitor of the barons of Strowan, chiefs of the Clan, and a second son, viz.,

Duncan, who became progenitor of the Robertsons of Inches, county Inverness. He settled as a merchant in Inverness during the reign of King James I., and died leaving a son and heir,

ROBERT, who carried on his father's business in Inverness, and being a successful merchant, became possessed of lands and houses in the neighbourhood of that town. He died, leaving a

son and heir,

John Robertson, the first of this branch of the Clan to assume the surname of Robertson. He granted a charter, 20th April, 1448, to William Michael, Burgess of Inverness, of a particate of land in "Doomsdale," Inverness, in which he is described as John, son and heir of Robert, son and heir of Duncan. John Robertson died in the reign of King James III. He had issue—Laurence and William. The elder son,

LAURENCE ROBERTSON, purchased a slated house in Inverness from the Monastery there. Charter for the same granted to "Laurence Robertsone by Henry Dewar, pryor of the Monasterie and Convent of Inverness, with the consent of the remanent breitheren, of one ruid of land in the head of the Bridge Street callit Sklaet House," dated 20th July, 1517. He married, and died leaving issue, a son,

JOHN ROBERTSON, Burgess of Inverness, served heir of his father in the reign of King James V. He died without issue,

and was succeeded by his uncle,

William Robertson, Burgess of Inverness, as shown by the "Service and Sasine in favour of William Robertson as heir to John Robertson, his nephew, son to Laurence, in roods, burgage lands, and houses, in Inverness and pertinents," 8th January, 1536. On the 18th October, 1522, there was an "Assedation by the Magistrates and Council of Inverness to William Robertson, Burgess of Inverness, of a timber shop appended to the Tolbooth." William Robertson married, and

died leaving a son,

John Robertson, Provost and Burgess of Inverness, a very strong and courageous man, hence he obtained the sobriquet of "Stalwart John." He acted as Lord Lovat's standard-bearer at the battle of Loch Lochy, 1544, fought between the Frasers and Macdonalds, and known to the Highlanders as "Blar-na-Leine" or the battle of the shirts. John Robertson was a successful merchant, and lived at a place still called "Robertson's Field," at Kinmylies, close to the Burgh. He married, firstly, a daughter of Hugh Rose of Kilravock, by whom he had issue, William, the elder, progenitor of the Robertsons of Inches; and Laurence, Burgess of Inverness, both living 1590. John Robertson married, secondly, Janet Simpson, as shown by the following:—"Instrument of resignation by John Robertson, Burgess of Inverness, to Janet Symmondson, for her life rent of

a rude of land on the Bridge Street," 28th October, 1551, and a "Charter by Janet Simpson in favour of John Robertson, her husband, and sasine of two roods of land in Doomsdale Street," 24th April, 1568, also, by an "Instrument of Sasine in favour of John Robertson and Janet Symondsone, his spouse, of the foresaid two roods in Demsdell," 6th April, 1570. John Robertson had issue by his second wife—

I. William Robertson the younger, of whom below as first

proprietor of Kindeace.

II. James Robertson, progenitor of the Robertsons of Shipland.

III. John Robertson, married and had issue.

IV. A daughter married to a son of Lord Lovat.

WILLIAM ROBERTSON the younger, Burgess of Inverness, was born before 1576. He carried on a good business in Inverness, and in 1615 purchased the lands of Urchany, county Nairn. In 1629 William Robertson purchased the lands, &c., of Kindeace, from which lands this branch of the family has since taken its title "of Kindeace." On 19th March, 1631, there was a charter under the Great Seal, to "Willielmo Robertson, burgen de Invernys, villae et terrarum de Easter Kindeace, &c., &c." He married Elspeth, daughter of the Rev. Thomas Howeson, minister of Inverness. The name of William Robertson of Kindeace appears in the Valuation Roll of the Sheriffdom of Inverness, including Ross, 1644, as a proprietor in the parishes of Kingscairn, Strathhockel, Rosskeen, and Nonekill. William Robertson of Kindeace died after 1646, having had issue,

I. William Robertson, who predeceased his father, without

issue.

II. Mr George Robertson of Kindeace, who died before 7th June, 1636.

III. Gilbert Robertson, of whom below as II. of Kindeace.

IV. David Robertson, progenitor of the Robertsons, farmers

of Drumnahoy, in the parish of Cluny, county Aberdeen. He was living, 1646. Now represented by James Elsmie, Esq., of Aberdeen, and by the descendants of the Rev. Alexander Cushny, D.D., Minister of Rayne, who married Ann Robertson, the elder daughter of the Rev. Alexander Robertson, of Coul, in the Presbytery of Kincardine O'Neil, by his wife, Mary, youngest daughter of Mr Robertson of Drumnahoy. David Robertson went from Inverness-shire and settled at Cluny, where he had the farm of Drumnahoy. He had issue,

1. John Robertson, farmer of Drumnahoy, who died aged

forty years, and was succeeded by his son,

(1). James Robertson, farmer of Drumnahoy, born 1663, died aged 98 or 100, and had issue—(1a) Andrew Robertson of Drumnahoy, merchant and brewer in Aberdeen, and also an Elder of the Kirk. He died about 1765, aged 82 years. (2a) A daughter, married to Mr Elsmie, and had issue—(1b) James Elsmie, who had his uncle's farm of Drumnahoy, and was ancestor of James Elsmie, Esq., and of George R. Elsmie, nephew to Mr James Elsmie, of Aberdeen.

V. Mathew Robertson of Docharty, or Docharty. There was a Mathew Robertson of Docharty in 1660 who married Margaret, daughter of Colin Mackenzie of Tarvie, and had a daughter, Margaret Robertson, married (contract dated 1680) to

Thomas Mackenzie of Cleanwaters.

VI. John Robertson.

VII. A daughter, married to Finlay Skinner, merchant in Inverness.

VIII. Margaret Robertson, married before 16th February, 1638, to Robert Mackintosh in Borlum, brother of Lauchlan Mackintosh of Borlum. He became Robert Mackintosh of Lynvuilg, but disposed of that property to his brother before 30th July, 1651. See sasines of these dates.

IX. A daughter, married to Robert Rose of Markine,

Provost of Inverness. For her issue see the printed genealogy of the Roses of Kilravock.

GILBERT ROBERTSON II. of Kindeace, merchant and burgess of Inverness. On the 7th June, 1636, he had a retour as heir male of his brother, Mr George Robertson of Kindeace, in the house and lands of "Eister Kindeace," and on the 10th January, 1643, as "haeres Magistri Georgii Robertsone, filli legitimi Willielmi Robertsone de Kindeis fratris," in the house and lands of Pitogartie. He married Margaret Mackenzie, daughter of Colin Mackenzie I. of Kincraig, as proved by the following sasine, 18th July, 1638, to "Margaret Mackenzie, fil. sen. leg. Colini Mackenzie de Kincraig, by Gilbert Robertson, fiar of Kindeis, with the consent of William Robertson, his father, of her liferent jointure lands as his future spouse." She married, secondly, John, son of Hugh Ross of Auchnacloich. On 31st August. 1649, Gilbert Robertson purchased Morewater and Pitmaduthie from Walter Ross, and on the 17th April, 1650, there was a renunciation of Easter Kindeace in favour of Gilbert Robertson. Gilbert Robertson of Kindeace (who died before 1669) and Margaret Mackenzie, his wife, had issue three sons and one daughter, viz.—

I. William Robertson, who predeceased his father. II. Colin Robertson, of whom as III. of Kindeace.

III. Francis Robertson, in Balcony, parish of Kiltearn, county Ross. On the 12th April, 1697, "John Bethine of Culniskea and Francis Robertson in Balconie" gave in a petition to the Session of Kiltearn to know what would be their share of what had been spent on the Kirk and Manse in 1691 and 1696, and in June, 1697, "Francis Robertson in Balconie and Gilbert Robertson, his son," contributed towards the repairing of the bridges of Skeak and Culcairn waters. He married Helen Ross, daughter of Hugh Ross of Easterfearn. Francis Robertson in Balcony and Helen Ross were buried in the Robertson burying-

ground, enclosed by an iron railing in the north-west corner of the Churchyard at Kiltearn, where there is a gravestone with the following inscription* on it:—

> Here lyes the ashes of Helen Ross, sometimes Spouse to Francis Robertson, in Balcony, who deperted this life the 5th of February, one thousand six hundred and twenty-seven.

He married Mary Oswald (who died 29th January, 1787), aunt of the late Mr Oswald of Scotsburn, and died 6th July, 1769. Issue—(1a) Harry, merchant in Glasgow. (2a) A daughter, married to Bailie Millar of Tain, and had issue.

(2). Hugh Robertson, farmer, of Balcony, married Ann, daughter of Robert Douglas in Ketwell, and had issue (see under the heading "The Descendants of Robert Douglas" in the

- (3). William Robertson, tenant at Teaninich, Alness, died October, 1770, married Catherine Ross, who died May, 1760. They were both buried at Kiltearn. Issue—(1a) John, of the Bank, Glasgow. He was the only owner of a private carriage in Glasgow at one time. Issue—two sons and six daughters. One son was called John Murdoch. Two Miss Robertsons at Large and Mrs Spens Munro were descended from John of the Bank. Issue—(16) John, an M.D. who lived at Rothesay, and had a son, Andrew, an officer in the Army. Dr George, minister of Campbelltown, Argyllshire, died (leaving issue) 8th September, 1820, aged 85. (5a) Gilbert, died abroad. (6a) Helen, married to George Munro, who died soon after he went to the West Indies. Issue—(1b) A son. (2b) Peggy, married to Hugh Ross, slater, from Milton of New Tarbat. No issue. (3b) Katherine, married to Joseph Robertson, Drummond, in Kiltearn. Issue—(1c) George, Tutor of Creich, who went to the West Indies, and married Paulina Vandermeulin. Issue— (1d) Joseph, died aged 21; (2d) Charles, married Harriet Hope of Liverpool. (2c) Barbara, Mrs Russel of Edinburgh. Helen, died unmarried. (4c) Jessie, died unmarried. Harry, of Newton, near Nairn, married Alice Pike. Issue—(1d) Catherine, married to Walter Arras, Esq., of Fodderty. Catherine and Alice Arras.
- (4). Janet Robertson, married to Robert Douglas, Balcony, and had issue (see under the heading "The Descendants of Robert Douglas" in the account of the Douglasses of Mulderg).

3. George Robertson, in Balcony, farmer, married before 1699, Christian, daughter of Hector Douglas, V. of Mulderg, and

had issue (see under the heading "The Descendants of Christian Douglas"). George Robertson was apparently living at the time of the death of his son, Robert, as he is not called "late" in the following inscription for a monument written by the Rev. Gilbert Robertson of Kincardine:—

> Here are deposited the relies of Mr Robert Robertson, son to George Robertson, in Balcony, a pious and judicious youth, who departed this life, June 29, 1723. As for me I will behold Thy face in righteousness. I shall be satisfied when I awake with Thy likeness.—Psalm xvii., 15.

IV. Janet Robertson, married to Alexander Ross of Easterfearn, son of Hugh Ross of Easterfearn. Alexander Ross was retoured heir of his brother german, Thomas Ross of Easterfearn, 15th August, 1694. Alexander Ross was a Commissioner of Supply 1685, 1689, and 1690. He died before 30th January, 1699, having had a large family by his wife, Janet, who died before 24th January, 1700. Janet Robertson had issue (with others)—

1. William Ross of Easterfearn, Bailie of Tain, who died 1727, having had with other sons and a daughter, Isobel Ross, wife of Thomas Ross of Calrossie, and mother of Katherine Ross, who married John Munro of Culcairn, and was great-grandmother of George William Holmes Ross, Esq., of Cromarty. Walter, third son of William Ross of Easterfearn, died 2nd October, 1721, of wounds received in Kintail while trying to

collect the rents of the forfeited Seaforth Estates.

2. Alexander Ross of Little Daan, W.S., died in London, 4th March, 1753, having had issue—David Ross, the famous tragedian, to whom his father (in his will proved in London) left a shilling a year to be paid on David's birthday, the 1st May, to remind him that he had better not have been born.

Elizabeth Ross (heiress of her father), who died July, 1793, married Hugh Ross of Kerse, Bailie of Tain, who, in June, 1721, killed Hugh Ross VI. of Achnacloich in a duel at Tain. She had several children.

3. Robert Ross, Bailie of Tain, who married Janet, daughter of Alexander Ross of Little Tarrell, and had, with others, Janet Ross, who married John Mackenzie, "Shipmaster," Cromarty, and was a widow 1745, and mother of Jean Mackenzie, who married Robert White, of the parish of St James', Westminster. He went to Tripoli in 1751 as Consul, and died 29th November. 1763, when the affairs of the Consulate were left in the care of his widow. Mrs White had only two children, namely—(1a)Robert White, Vice-Consul of Tripoli, died there 1769. Jannetta White, married 26th April, 1756, at Tripoli, to Cosimo Michelangelo Conti, Count of the Holy Roman Empire. died at Florence, 18th May, 1800. Issue—(1b) Giovanni Conti, Marchese di Trevignano, married 13th August, 1804, Besola, daughter of Marchese Pompeo Bourbon del Monte, and dving at Florence, 21st March, 1828, left issue—(1c) Cosimo Maurizio Conti, Prince of Trevignano, who died without issue at Albano, 2nd July, 1855, having married Adelaide, daughter of Prince Tommaso Corsini; (2c) Maria Anna Teresa Conti, born at Piza, 4th May, 1812, married to Giovanni Ginori, by whom she was mother to Gino Ginori-Conti, Prince of Trevignano on the decease of his uncle, and Emilia Genori-Conti, married to Major Ignazio Oppenaner. (2b) Jannetta Conti, died at Hampstead, 18th July, 1780, and buried there. (3b) Elizabeth Carolina Conti, married to Filippo Buonarroti, and had issue. (46) Maria Caterina Fellippa Conti, died unmarried, 1799. (The information about Janet Robertson and her descendants is reprinted from the Ross Pedigree, by Mr Reid, in "Northern Notes and Queries," by kind permission of the Rev. A. W. Cornelius Hallen of Alloa.)

Colin Robertson, III. of Kindeace, married Rebecca, sister of Sir John Munro, 4th Bart. of Fowlis, and only daughter of Sir Robert Munro, 3rd Bart. of Fowlis, by his wife, Jean, eldest daughter and co-heir of Colonel Sir Hector Munro, 1st Bart. of Fowlis and his wife, Mary, full sister to Donald, Lord Reay, and daughter of Hugh Mackay of Far (Strathnaver) by Lady Jean Gordon, daughter of Alexander, Earl of Sutherland. Through her great-grandmother, Lady Jean Gordon, Rebecca Munro (like her mother-in law, Margaret Mackenzie) carried the blood of the Plantagenets, Bruces, and Stewarts into the Kindeace family. He had a retour 16th April, 1691, "Colinus Robertsone de Kindeass, haeres masculus Gilberti Robertsone de Kindeass, patris." Colin Robertson and Rebecca Munro had issue—

I. William Robertson, of whom below as IV. of Kindeace.

II. George Robertson, Sheriff-Depute and Commissary of Ross. He was living 3rd May, 1722, but died before 24th March, 1752, as on the latter date his son Andrew, then Clerk of Dingwall, was retoured heir of his father. George Robertson married Agnes, daughter of John Barber of Aldowrie, county

Inverness, by whom he had issue—

1. Andrew Robertson, Esq. of Blackwells, near Dingwall, and of Park House, Dingwall. He was a Writer, Sheriff-Substitute of Ross-shire, and three times Provost of Dingwall. Andrew Robertson married 12th April, 1760, Anne, daughter of Colin Mackenzie, Inn Keeper, and Bailie of Dingwall, by his wife, Mary, only daughter of Kenneth Mackenzie II. of Torridon, who married Ann, daughter of Alexander Mackenzie, VII. of Gairloch. III. The Rev. Robert Robertson, A.M., minister successively of Loth, 1721 to 1730, and of Edderton, 1730 to his death, 13th December, 1740. He had his Degree 13th April, 1710. It was during Mr Robertson's time, and from the parish of Loth, that the last unfortunate victim suffered for witchcraft, being burned to death at Dornoch.

IV. James Robertson, bred to the sea.

William Robertson, IV. of Kindeace, a cavalry officer, who was, during his father's lifetime, called "Cornet William Robertson of Urchanny." He married twice—firstly, Catherine, daughter of Robert Robertson of Shipland (a descendant of James, fourth son of John Robertson, Provost of Inverness), by whom he had issue. His second wife was his cousin german, Ann, sister of Mrs Peter Bethune of Culniskea, and daughter of Sir John Munro, 4th Bart. of Fowlis, "The Presbyterian Mortarpiece." William Robertson had issue (only by his wife Catherine) several daughters and the following sons—

I. Charles Robertson, of whom below as V. of Kindeace.

II. Captain Archibald Robertson, witness to the marriage at Ardullie, 14th October, 1766, of his cousin, Miss Jane Bayne (daughter of the Minister of Dingwall), with Captain William Douglas of the Marines, who lived at Fyrish. He was, perhaps,

the "Captain Archibald Robertson of Ardelzie," who with "his spouse, Margaret Robertson," purchased Rosebank, Nairn, on the 18th May, 1773, and sold it again the same year to Hugh Ross of Brea.

III. (?) Duncan Robertson, perhaps another son Duncan, as on the 31st of August, 1756, a "Duncan Robertson of Kindeace"

was admitted honorary burgess of Nairn.

CHARLES ROBERTSON, Esq., V. of Kindeace. In 1740, while "Charles Robertson of Urchanny," he was appointed Sheriff-Depute of Nairnshire, an appointment from which he retired in 1742. About the middle of the last century he purchased, for £500 sterling, from Munro of Culrain, the north part of the estate of Kindeace, viz., Torran, Kinrine, and Strathrory. Charles Robertson married Janet (born about 1738), only daughter of Hugh Rose of Clava, county Nairn, by his wife, Frances, only daughter of Æneas Macleod of Cadboll, county Ross, and Margaret Mackenzie (married 13th February, 1703), daughter of Sir Kenneth Mackenzie, 1st Bart. of Scatwell. Janet Rose also carried the blood of the Plantagenets, Bruces, and Stewarts into the Kindeace family, through her descent from the Mackenzies of Scatwell. She was buried at Rosskeen. where there is a monument to her erected by her husband, the inscription on it being as follows:-

> Erected by Charles Robertson of Kindeace over the burial place of his ancestors and in memory of Mrs Janet Rose, his Spouse, who died, at Catboll, 23 Febry., 17-82, aged 44 years. To her to live was Christ and to die was gain.

Charles Robertson of Kindeace died before the 9th May, 1792,

as his son William is retoured heir of his father on that date. Issue—

WILLIAM ROBERTSON, Esq., VI. of Kindeace, J.P., D.L. for county Ross, Major of the Ross-shire Militia, born 2nd February,

1765, married 20th December, 1788, Mary, eldest daughter of Alexander Chisholm, Esq. of Chisholm, by his second wife, Margaret, daughter of George Mackenzie, II. of Allangrange, and Margaret Bayne (senior representative general of the Baynes of Tulloch), daughter and sole heiress of Duncan John Bayne, younger of Tulloch (by his wife, Margaret, youngest daughter and co-heir of Sir Roderick Mackenzie, Knight, of Findon), and grand-daughter of Sir Donald Bayne, Knight, of Tulloch. Through her ancestors, the Chisholms of Chisholm, the Mackenzies of Allangrange, the Baynes of Tulloch, and the Mackenzies of Findon, Mary Chisholm carried the blood of the Plantagenets, Bruces, and Stewarts into the Kindeace family. This is the fourth time the Royal blood is transmitted to the family. Mary Chisholm died 1800. William Robertson died 7th April, 1844, and was buried at Homerton, London. Issue—

I. Charles Robertson, of whom below as VII. of Kindeace. II. Alexander Robertson, born 1794, an officer in the 42nd Royal Highlanders. He exchanged into the 24th Regiment of Foot, and died in April, 1820, on his passage to join his regiment in India.

CHARLES ROBERTSON, VII. of Kindeace, a Major in the 78th Highlanders and 96th Regiment. He was present at the capture of Java. Charles Robertson was born 26th July, 1790, and married on the 12th August, 1816, Helen Cruickshank, who died at Kindeace, 1860, fourth daughter and co-heir of Patrick Cruickshank, Esq. of Stracatheo. Major Robertson died 17th October, 1868, and was buried at Rosskeen. Issue—

I. William Robertson, younger of Kindeace, born 17th May, 1817, married 5th September, 1860, Euphemia, daughter of Major Donald Mackay, of the Bighouse family. William Robertson died at Dingwall in August, 1867, and was buried at Rosskeen. Issue—

The Arms of Charles Robertson, Esq., now of Kindeace.

Arms:—Quarterly, 1st and 4th, "Gules, three wolves' heads, erased, Argent, armed and langued, Azure, within a bordure, engrailed, of the First," for Robertson; 2nd and 3rd, "Argent, three boars' heads, couped, Sable, armed and langued, Gules, within a bordure, of the Last," for Cruikshank. On a compartment under the arms, a wild man in chains lying.

Crests:—"A dexter arm holding up an imperial crown, Proper," also "a swan, Proper."

Mottos:—"Virtutis Gloria Merces" and "Vite faciendo nemine timeas."

It is doubtful if the Robertsons of Kindeace should not also quarter the arms of the Robertsons of Shipland, which Mr Robertson of Kindeace gives as—

Arms:—"Gules a water budget, between three wolves' heads, erased, Argent, armed and langued, Azure."

The Arms, Crest, and Motto, of the Robertsons in the parish of Kiltearn, and of Chilcote Hall, were the same as those of Provost Andrew Robertson of Dingwall.

Copy of a letter from Charles Robertson, Esq. of Kindeace, to Raymond Tinne Berthon, Esq.:—

Kindeace, Delny, Ross-shire, N.B., 6th Nov., 1892.

Dear Sir,—I am sorry I cannot give you all the information you want, but I have looked up Strowan's old old book and have found there some writing, either my grandfather's or great-grandfather's, on the margin of the writ of the family of Gilbert Robertson, II. of Kindeace. The printed part says he had three sons and two daughters, thus:—

- 1. William
- 2. Colin.

3. ———, and two daughters, Frances and Janet.

But the correction in the faded writing is different, and reads as follows:-

1. William.

2. Colin.

*3. ____ [and two daughters], Frances, "one daughter, Janet,

who married, and had children-Gilbert, George, and others."

I have copied the corrections, only adding quotation marks. You will see that it leaves Frances as the third son's name, though spelt with an "c." Frances is a woman's name generally. I think I can explain how George came to be put in by Burke. You mentioned 1838 as the date in which it first appears. I find from a document of my father's that he gave the name as George in 1828, and sent it to Mr Colburn, New Burlington Street. On what authority he gave the name as George, I do not know.

Extract from a letter dated 27th August, 1894, written to Mr A. M. Ross, Publisher, Dingwall:—

"Some considerable time ago I sent to ——— a note to serve as the foundation of an introduction to his book. This told that the Douglases appeared in Ross-shire about the time that the Earl of Morton, Regent for Scotland, and a Douglas, claiming to be the representative of that great family, was beheaded.

"This Earl favoured what was called the Reformed Church, as against the

Roman Catholic or Jacobite party, who for a time got the upper hand.

"The tradition—for if any documents exist, I know not of them—was common among descendants of Easter Ross Douglases in my early youth, that they were descended from some of the Eurl of Morton's followers, who fled there during his accusation and death. Manifestly they were possessed of some means or influence, for they immediately acquired land.

"The Morton Douglas family have been Reformers and Whigs, as against the Jacobite faction of the families now represented by Home and Queensberry."

The value of this tradition cannot be ascertained, but it may be well to state that the arms, crest, and motto borne by the descendants of the Douglases of Mulderg are exactly the same as those borne by the Queensberry family, except that the wings in the crest are dove colour instead of or.

Munro of Culrain case, states that she was the daughter of Quarter-Master William Munro, and that her father was on military service along with Sir Robert Munro, the grandfather of the defender, Sir Hugh Munro, and that her father, upon returning from service at the peace of 1763, got a farm from Sir Harry Munro, the son of Sir Robert Munro, upon the estate of Fowlis, also that the farm her father got is called Ketwell, and that she was born there and had all her life been resident on the estate of Fowlis. She states that she at present (1833) occupies the house and farm of Ardullie, at a rent of £587 per annum, and that there was a great intimacy and friendship between her father and Sir Harry Munro after her father left the army and settled at Ketwell.

Page 16.—Duncan Douglas of the Custom House, Inverness, died about 1810, and was buried at Kiltearn.—Letter of Mr John Munro, factor of Fowlis, dated 6th January, 1860.

Page 21.—Ann Robertson, daughter of George Robertson, in Balcony, parish of Kiltearn, married Finlay Munro of Lealty (son of Donald Munro of Lealty and Helen Simson, his wife), and had issue—
